Who is providing this notice?	The Voss Auto Network includes Voss Toyota, Voss Village Cadillac Inc., Voss Village BMW, Voss Chevrolet, Inc., Voss Honda, Voss Hyundai, Voss Auto Network Inc., and Joe Morgan Honda.
What we do	
How does Voss Auto Network protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We restrict access to your information to those who need it. We educate our employees on the importance of protecting your information. We take our responsibility to protect your information seriously.
How does Voss Auto Network collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> ■ apply for financing or provide employment information ■ give us your income information or give us your contact information ■ show your government-issued ID We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> ■ sharing for affiliates' everyday business purposes—information about your creditworthiness ■ affiliates from using your information to market to you ■ sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ■ <i>Our affiliates include companies with a Voss name and others, such as motor vehicle dealerships within our dealership group.</i>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ■ <i>Voss Auto Network does not share with nonaffiliates so they can market to you.</i>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> ■ <i>Our joint marketing partners include automobile manufacturers, providers and/or administrators of aftermarket products, financial institutions, insurance companies or agencies, and companies that provide marketing services.</i>
